## **Announcement Regarding Nomination of Candidates for Director**

INFRONEER Holdings Inc. (the "Company") hereby announces that the Nominating Committee passed a resolution on April 21, 2025, regarding the election of candidates for the Board of Directors to be proposed at the 4th Ordinary General Meeting of Shareholders, scheduled to be held in June 2025.

### 1. Reasons for Change in Governance System

We have adopted the "Company with Nominating Committee" system of corporate governance, which clearly separates the functions of management supervision and business execution to ensure fairness and transparency of management and to establish an execution system that enables prompt management of business operations.

In order to further promote this approach, the Board of Directors has resolved to change to the following structure with the aim of achieving the Mid-term Medium-term Management Plan and further increasing corporate value by further delegating authority to the executive side, with the Board of Directors specializing in the supervisory function over business execution.
